

International Organization Employment

F-1 students are authorized to work off-campus for no more than one year at a recognized international organization given the student continues a full course of study in F-1 status during the period of employment. The student must apply for an Employment Authorization document (EAD) through USCIS and be approved before commencing employment with an organization

Eligibility

- Student is eligible as soon as they have entered the United States in F-1 status and been registered as a full-time student on campus. Only eligible **before** the completion of the academic program.
- Have received a written offer from a qualified international organization (see list below) for a position that would not otherwise qualify for a G-visa.
- Must maintain a full course of study during the internship.

Application Process

Allow at least 10 business days for ISO processing. The ISO is not responsible for USCIS processing times.

HOW TO APPLY FOR WORK AUTHORIZATION FOR AN INTERNATIONAL ORGANIZATION

- 1. Obtain a written offer on letterhead from the international organization describing the proposed internship and the scope of the organization's sponsorship.
- 2. Submit the written offer, a complete <u>ISO request form</u>, a copy of your passport, visa and I-94, and completed form I-765 to the ISO front desk for review by an ISO advisor.
- 3. After receiving a new I-20 with the recommendation for employment authorization with an international organization from an ISO DSO, submit all documents to USCIS following the <u>instructions on their website</u>.
 - a. Documents submitted to USCIS include: Form I-765, two (2) passport-sized photos taken no more than 30 days prior to filing, a copy of the signed I-20 with DSO recommendation on Page 3, letter from the international organization, a copy of your recent <u>I-94</u>, copies of passport, copies of any previously issued EAD, and a check or money order must accompany the submission to USCIS
